

KELLOGG™ GRAB AND GO BOLDLY SWEEPSTAKES

OFFICIAL RULES

- PROMOTION DESCRIPTION:** The *Kellogg's™ Grab and Go Boldly Sweepstakes* (the "**Sweepstakes**") is a monthly social media Sweepstakes that begins on 1/1/18 at 12:00:00 AM Eastern Time ("**ET**") and ends on 6/30/18 at 11:59:59 PM (ET) (the "**Promotion Period**").

Throughout the Promotion Period, eligible entrants will have the opportunity to snap a photo of how you (the entrant) "Grab and Go Boldly" (optional: include a Participating Product in your photo) or post a phrase or sentence about how you "Grab and Go Boldly", and then share your photo or your phrase/sentence in the form of a post on Facebook, Instagram or Twitter (the "**Submission**"), as more fully set forth below. "Participating Products" include *Kashi® GOLEAN®* bars, *Pure Organic™* bars and *Bear Naked®* bars. For purpose of this Sweepstakes, a "Month" is defined as a standard calendar month and a "Day" is defined as any 24-hour period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET). There will be one (1) Grand Prize winner for each Month in the Sweepstakes that will be randomly selected at the conclusion of each respective Month. Non-winning Monthly entries will not rollover into any remaining Monthly drawing(s).

By participating in the Sweepstakes and posting a Submission using the "Hashtags" (as defined below), each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Kellogg Company ("**Sponsor**"), which shall be final and binding in all respects.

- ELIGIBILITY:** Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia and are eighteen (18) years of age or older at time of entry. Employees of Kellogg Company, its parent company, their subsidiaries, affiliates, advertising, promotion and other agencies (collectively, the "**Promotion Entities**"), and their immediate family members and/or those living in the same household of each are not eligible to participate. - HOW TO ENTER:**
 - Facebook Entry.** You may enter the Sweepstakes via Facebook by going to <https://www.facebook.com/GrabNGoBoldly/> to connect to the Sweepstakes Facebook page. Then, complete your Submission (including posting your photo, if applicable) directly on Sweepstakes Facebook page to enter the

Sweepstakes along with the hashtag **#grabandgoboldlyentry** (the “**Hashtag**”). You must post your Submission (and photo, if applicable) and you **MUST** include the Hashtag for your Submission to be eligible as an entry into the Sweepstakes. You must be a registered Facebook member to enter via the Facebook method of entry. Facebook account registration and Sweepstakes entry is free.

- b. Instagram Entry. You may enter the Sweepstakes via Instagram by going to <https://www.instagram.com>, log into your Instagram account and post your Submission along with the Hashtag. Submission must be posted to the entrant’s non-private Instagram account and **MUST** include the Hashtag to be eligible as an entry into the Sweepstakes. You must be a registered Instagram member to enter via the Instagram method of entry. Instagram account registration and Sweepstakes entry is free.
- c. TWITTER. You may enter the Sweepstakes via Twitter by logging into <https://www.twitter.com>, log into your Twitter account and tweet your Submission along with the Hashtag. All Twitter Submissions must be posted to a non-private Twitter account and **MUST** include the Hashtag to be eligible as an entry into the Sweepstakes. You must be a registered Twitter member to enter via the Twitter method of entry. Twitter account registration and Sweepstakes entry is free.

Direct any questions, comments, or complaints regarding the Sweepstakes to Sponsor, not Facebook, Instagram or Twitter. Limit one (1) entry per person, per Day in the Sweepstakes – regardless of method of entry.

Each Submission must meet the following “**Submission Requirements**” (any Submission that, in Sponsor’s sole and absolute discretion, violates the following criteria will be disqualified):

- Instagram and/or Twitter Submissions must be posted to a non-private social media account; Facebook Submission must be posted via the Sweepstakes Facebook Page; the social media accounts associated with this Sweepstakes can be obtained for free at the respective social media platform or in the applicable app store;
- If a photo is included in the Submission, the photo may not include any individual other than the entrant in the Submission.
- Entrant must be the rightful owner of the social media account associated with the Submission; and must be the rightful owner of any photo included with the Submission;
- Submission must comply with the social media platform’s terms and conditions as posted on the respective social media platform;
- Submission must **NOT** contain subject matter which is, or could be considered, in the sole discretion of the Promotion Entities, obscene, pornographic, violent (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), defamatory, libelous, discriminatory (based on race, sex, religion, natural origin, physical

4. **WINNER SELECTION AND NOTIFICATION:** Six (6) Grand Prize winners (one (1) winner each Month) will be randomly selected from all eligible entries received during the respective Month on or about the next business day after the end of the Month by Sponsor or its designee, whose decisions are final. Any potential winner will be the entrant of the Submission that is associated with an entry that is randomly selected as a winning entry, subject to eligibility verification. Potential winner will be notified via direct message within seventy two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within two (2) business days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected.
