Central Program Incentive Reward will consist of one (1) \$50 voucher and customizable point-of-purchase (“POP”) materials for their school or eligible off-premise summer feeding locations, including a poster and digital assets that can be used for a school district’s or eligible off-premise summer feeding locations social media/website. Maximum number of rewards that can be earned for each participating K-12 School District or eligible off-premise summer feeding location is twenty five (25) vouchers (max. amount \$1,250). Vouchers are subject to the terms and conditions associated with their use. See \$50 printed voucher for expiration date.

3. For Central Program Incentive Rewards - once the Qualifying Purchase requirements are met (and validated by Sponsor), eligible K-12 Foodservice Operators **at the District Level** and eligible off-premise summer feeding locations will receive a printed card with a unique web code for each \$50.00 voucher which will be used to redeem the voucher via an online redemption website. Vouchers will only be awarded to qualifying K-12 Foodservice Operators (District Level only) and eligible off-premise summer feeding locations based on a Qualifying Purchase (i.e. ...purchase of twenty (20) incremental cases of Participating Products...). To achieve incremental vouchers, each K-12 School District or eligible off-premise summer feeding location must purchase incremental groupings of twenty (20) cases (ex.: if you purchase twenty (20) incremental cases of Participating Products, you will receive one (1) \$50.00 voucher; if you purchase thirty nine (39) incremental cases of Participating Products, you will still receive one (1) \$50.00 voucher; to achieve two (2) \$50.00, you must purchase a total of forty (40) incremental cases of Participating Products during the Promotion Period). Non-printed material will be provided from the designated sale representative digitally.
